#### Report of Officials:

#### Police Chief- Whitaker-

- GPD has investigated three (3) separate and unrelated sex crimes in the past week. Suspects are identified in all three investigations and charges have been submitted on two of the three investigations. The remaining case will be sent to the next session of the grand jury. All three involve juveniles.
- Two GPD officers are attending Ohio Juvenile Officer Association training this
  week in Eastlake, Ohio. The Officers will learn new investigative techniques,
  updated laws relating to juvenile crime, juvenile trends with drugs among many
  other topics. The will return Friday. Juvenile crime in Gibsonburg comprises
  more than half of our total crime stats.
- The Drug Task Force levy passed. The advisory board will meet next week to discuss several topics to get the DTF in new quarters and hire additional staff. I have drafted a letter to the county commissioners requesting funds to be borrowed from the county against the DTF levy funds which will not come in until February 2018. I have already had discussion with two of the commissioners to arrange this. If this does in fact happen, we [Village of Gibsonburg] may not have to make our second half pledge of \$ 2500 to the DTF. Will keep council and fiscal formed of this.
- Will be hiring a replacement for PO William Pelish badge # 721. PO Pelish has submitted a letter from his surgeon stating that he would be at risk for injury if he returned to work as a street officer. This disqualifies him for duty. I have begun interviews with "very" limited available candidates. Hopefully will have one selected and submitted to council for approval by summer.

### **Residence- Open Forum/Comment:**

Cindy Oller had questions regarding the ballpark entrance and exit. Marc stated they are working on this with the ball association. Also asked about Alley's and what they are to be used for.

Mike Shields is there a way that is there is an incident at the school that harms someone that it can be taken further? Chief Whitaker stated it happens all the time and they look into it.
