- CDBG Targets of Opportunity- We are in the process of resubmitting our CDBG
  application that was filed in April to the State of Ohio for consideration of the CDBG
  Targets of Opportunity Program.
- Exterior Maintenance Issues- We have been actively dealing with a number of exterior maintenance issues throughout town. For the most part, things have been received about as well as they could be and the homeowners have been working towards addressing the issues.
- Solicitation Ordinance- A rough draft has been sent to Solicitor Ruck for his review and comment.
- Christmas Decorations- We are in the process of identifying some new Christmas
  decorations for the downtown area and we hope to have them ordered by the end of
  August. We're looking at LED displays that will mount to the existing light poles
  downtown.

#### Report of Officials:

#### Police Chief- Whitaker-

- 1. Attended Heroin/Fentanyl conference in Perrysburg last Thursday. Very good information exchange. Learned that Wood County had only 13 fatalities last year compared to Sandusky County's 26.
- 2. GPD will be hosting a Naloxone (Narcan) dispensing training on August 2. Will be instructed by a nurse from the Sandusky County Health Department. Woodville PD officers will attend. GPD will begin carrying Naloxone on-board police cars sometime after the training. Officers have already taken an online Naloxone training class via the Attorney General's Office. GPD has made numerous arrests and seizures of heroin, fentanyl and other illicit drugs over past two years and officer exposure has increased. We will use the Naloxone for officers and the public if needed.
- 3. Property Crimes are extraordinarily low compared to previous months and same time last year. Attributed to: a. Successful prosecution of teens.
  - b. Extra weekend patrol.
- 4. One of the escaped prisoners from the Sandusky County Jail had been arrested by GPD in March of this year. Mickey Hardy was picked up on a warrant and we recovered a car he had stolen from Fremont. He was living above the fitness center downtown with his girlfriend.
- Would like to thank Council for officially recognizing and resolving to support GPD's Explorer Post.
