- **LTCP Project-** B Hillz has been notified of being awarded the contract and we will be setting up the first preconstruction meeting soon.
- **Gibsonburg EDC-** Attached with this report is a copy of a clean audit letter from the State of Ohio. This audit covered the years of 2019 and 2020.
- Ohio EPA 2020 Public Water Tracking Metrics- We continue to work on and prepare our report to the Ohio EPA to satisfy their requirement of the submittal of tracking metrics.
- **Exterior Maintenance-** We continue to follow up on issues when they are observed and/or reported. There has been a great deal of movement involving addressing concerns at many properties and we truly appreciate those property owners who have been working with us.
- **Bulk Trash Drop Off-** Scheduled for Friday, July 30<sup>th</sup> (8am to 4pm) and Saturday, July 31<sup>st</sup> (8am to 12pm) at Town Hall.
- **Fishing Derby-** The event took place on June 5<sup>th</sup> at Williams Park from 9am to 11am and had about 45 total participants. Final Reports for the ODNR Grant will be completed and sent in next week.
- **Movie Night at the Logyard-** Movie Night at the Logyard will take place on Saturday, July 10<sup>th</sup>. We will be showing "The Sandlot" and have some other things planned for the night. More information to come.
- 9/11 Ceremony- We have begun the process of putting together the ceremony that will be held at the Public Safety Service Memorial at 12:00pm on Saturday, September 11<sup>th</sup>. More information to come as we get closer to the date.

### Fiscal Officer's Report:

- We are getting close to conversion time to transfer all income tax processing and payments to RITA. Transfer to RITA will take place on July 1, 2021. Credit card payments thru the Village website will be suspended as of June 27<sup>th</sup> and will be redirected to the RITA website.
- Recommend to hire Julie VanNest as temporary Fiscal Officer while Jeff is out of the office for vacation the week of July 12<sup>th</sup> and also for scheduled surgery on July 28<sup>th</sup> and at least 2 weeks recovery time after. I will not be at the July 16<sup>th</sup> and the August 5<sup>th</sup> council meetings.


