Mayor's Report:

- Thank you to Ken Cantrell for long service to community. Appreciate all service.
- Christmas is next week, enjoy your families.

Administrator's Report:

- **E. Yeasting/Rodriguez Street Paving Update-** Project completed. There are a few spots near Reino Linen that we have requested them to come back and take care of in the spring.
- **LTCP Project-** Project is completed for the year. B Hillz will be back for the remainder of the work to be completed in the spring.
- **613 E. Madison Street-** The house has been completely demolished and property cleaned up. Big thanks to the Rudinoff Family as they made a significant personal investment in taking care of the issue by purchasing the property from Tax Ease and having the house demolished and property cleaned up.
- **Transportation Alternatives Program-** We are still working on the full application with the assistance of Poggemeyer and will have it submitted by the deadline.
- **EOC/COVID-** We continue to follow the issue and will pass along any information that we receive. The rapid test kits that we received are expired, but it is our understanding that this is a common issue now and EMA and Health Department are working towards a resolution so that even test kits with an expired date on them can still be used. We have them in storage, but will not pass them out until the issue has been resolved.
- **Traffic Light-** As you all are aware there was a malfunction in the control panel on December 7th. This was likely caused by a power surge. Since that time the light has been flashing as a four way stop. Miller Cable has been working with us on the repairs. Unfortunately, due to the supply chain issues and the holidays, it is looking like it may be a four way stop for just a little while longer as they wait on the arrival of the new control panel. Based on the number of comments received about considering keeping it as a four way stop, we have reached out to ODOT for them to weigh in on the ability to do so.
- **Bureau of Workers Comp Inspection-** The area's Safety and Compliance Officer was here last Wednesday for a surprise inspection. He toured: Town Hall, WWTP, Water Plant and Street Garage. There were some minor issues that we will have to address

- within six months. Mostly "de-cluttering" some areas and disposing of some older items like paint cans, etc....
- **EPA CSO/NPDES Permit Inspection-** Representatives from the Ohio EPA were in town on Wednesday, December 15th to tour and inspect the CSO's, our compliance with our NPDES Permit and review some newer guidelines associated with them. No issues to report and with the completion of the first portion of the newest LTCP Project, we are back on schedule with that portion of our permit.
- Old Fifth Third Bank Building- No further updates at this time.
- **E. Yeasting/Rodriguez St Annexation-** As a reminder, the Public Hearing for the annexation is scheduled for 9:30am on January 6, 2022, at the Sandusky County Commissioner's Office on Croghan Street in Fremont. All of the residents in the neighborhood have been notified.
- **Safety Railing-** Safety railing along the west side sidewalk of the railroad crossing on S Main Street will be installed soon.
- **R3 Initiative-** The Steering Committee has met for the final time in 2021 and will begin to meet again in January. There are some exciting things coming up in 2022 associated with the R3 Initiative. As a reminder, there is a Gibsonburg R3 Facebook Page now and I encourage everyone to check it out ("Gibsonburg R3").
