Mayor's Report:

• Reminder that with good weather a lot of kids running around, so be careful when driving in the Village.

Administrator's Report:

- **Omni Fiber-** No further updates available regarding plans for review and a completed ROW Permit as they both have still not been submitted by Omni Fiber.
- ARPA Funds and Report- The information related to the ARPA Funds given to the Village of Gibsonburg has been submitted. Pending any errors made on our end, this should conclude the ARPA process for Gibsonburg.
- Congressionally Directed Spending- Congresswoman Kaptur's Office reached out to us last week and requested that we update and resubmit our information for CDS Funds for FY 2026. We had everything to them by the Friday, April 18th deadline they set.
- **Homecoming Beer Resolution-**On the Agenda tonight is the Resolution to temporarily suspend the prohibition of alcohol in Williams Park for the Homecoming Festival in June.
- **ODOT Salt Contract Resolution-** On the Agenda tonight is the Resolution to participate in the ODOT 2025/2026 Winter Road Salt Contract. We have committed to purchasing 100 tons, which is 25 tons more than the past few years. With modifications made to the storage area, we are able to take delivery and store more materials.
- **Planning Commission/Hahnco Resolution-** HAHNCO presented their plan to build a new convenience store on their property during the Planning Commission Meeting on April 3rd. At that time, they requested from the Planning Commission a variance related to the size of the rear lot for a building in the C1 Business Office District. The Planning Commission approved their request by Resolution, which has been forwarded to Council tonight for full consideration.
- **CR 85 Tour-** No further updates since the last meeting. Again, we have submitted all of the follow-up information as requested by all groups involved.

- Sandusky County Land Bank- Two properties are on the Sheriff Sale list for April 23rd: 414 S. Gibson (vacant lot) and 305 E. Stevenson. If a no bid is received for one or both properties, they will immediately be given to the Land Bank by court order. The S. Gibson Street property will be advertised for sale by the Land Bank and the E. Stevenson Street property will be demolished by a joint effort between the Land Bank and the Village.
- **Logyard Electric-** Electric is scheduled to be installed at The Logyard during the first of May. Once this has been done, we will seed/sod the area.
- **ODOT Safety Grant-**We met with ODOT staff last week for the safety upgrades on SR 300 near the Middle School/High School. The project will include new crosswalks, solar powered pedestrian crossing signals, a walkway from Linden Ave to the school driveway and other safety signs. Intentions are to have it completed this summer.
- **M&B Paving:** No firm dates yet from M & B for paving work to be done on: Ohio Street, Hurlbut Street and Suter Street. They will likely be late summer project dates.
- **Downtown Project Design-** Colliers and staff met with staff from ODOT for the initial Project Scope Walkthrough for the TAP Grant on April 22nd.
- Water and Sewer Rate Study- We are working to set up a final meeting with the staff from Ohio Rural Water No Ohio Rural Water on the Water and Sewer Rate Study and will forward that information as soon as it has been set.
- Vibrant Community Grant/Pharmacy- We are in the process of collecting Letters of Support and finalizing our proposal to make our "pitch" to JobsOhio on the project. Everyone agrees that it is an amazing project for Gibsonburg, and we are looking forward to getting in front of the staff at JobsOhio and making our pitch to bring grant funds to town for the project.
- **Easter Egg Hunt-** Big thanks again this year to Lauren Hacker of Polter Realty for once again sponsoring an Easter Egg Hunt in Williams Park on Saturday, April 19th.
- May 1st- I will be out of the office on May 1st.
