Your monthly bill will consist of the following minimum charges:

2026 In Town Rates 3/2025

Base Water: \$23.50
Base Sewer: \$45.51
Garbage Pickup: \$21.00
TOTAL: \$90.01 (up \$2.96)

2026 Out of Town Rates

Base Water: \$47.35
Base Sewer: \$68.26
TOTAL: \$115.61

In **addition** to the above, your bill will consist of additional charges based on the actual number of units of water used. (Each unit is 748 gallons).

Water: \$2.30 per unit - in town Sewer: \$1.50 per unit - in town (**\$3.80 up (\$.10)**)
Water: \$3.30 per unit - out of town Sewer: \$2.25 per unit - out of town (\$5.55)

Bills are mailed/emailed out at the end of the month and are **DUE on or before the 15th**, IF NOT PAID by the 15th there will be a penalty of 10%. These bills can be paid the following ways: mailed to 526 N. Webster St., pay in the office or drop box out front. Payments accepted are: CASH, personal checks, money orders, cashier checks, auto deduct from savings or checking account (with proper paperwork filled out) or credit cards with a **processing fee of 3.5% and an account must be set up at <https://gibsonburg.ohiobillpay.com/>** you will need your account # and Pin # which is on your bill.

GARBAGE: MONDAY'S STEVENS DISPOSAL 4/2026

Please have trash can out by 6:00 AM. It should be placed at the curb no earlier than 24 hours prior to pick up. All empty garbage cans/barrels must be removed from the curb within 24 hours.

Each household will be supplied with a 96-gal tote from Stevens. If you feel you would like a second tote, you may get another one with a \$30 delivery fee, but no added monthly cost to you. Please contact Stevens.
